OPASTCO and WTA MEMBERS KICK OFF L&R CONFERENCE WITH JOINT BRIEFING AND KEYNOTE ADDRESS BY CONGRESSMAN LEE TERRY

A Record Breaking 140 Rural Advocates Carry Messages on USF, Intercarrier Compensation, Broadband and Video Content to Capitol Hill

WASHINGTON – At the first-ever joint Organization for the Promotion and Advancement of Small Telecommunications Companies' (OPASTCO) and Western Telecommunications Alliance (WTA) 2008 Legislative & Regulatory Conference in Washington, D.C., 140 rural advocates traveled to our nation's capital to be briefed on crucial rural telecommunications issues and educate their members of Congress on how these issues affect their home districts. Keynote Speaker Congressman Lee Terry (R – Neb.) stated, "My goal is to make sure that everyone has access to the best communications," and cited his continuing efforts with Rep. Boucher to promote the Universal Service Reform Act of 2007 on the Hill. Terry also applauded the efforts of attendees to bring broadband to rural America, "Those in the room have done an excellent job of providing advanced services in their areas."

Regarding the joint conference, WTA Executive Vice President Kelly Worthington explained, "On many issues, WTA and OPASTCO share similar positions. It was a natural fit. The conference also was an opportunity for WTA members to add their voices to OPASTCO's during this push to educate the Hill about universal service, phantom traffic, broadband and video content."

"The combined conference adds value for all of our members," OPASTCO President John Rose stated. "The more rural telecommunications representatives we can get to lobby Capitol Hill, the more our message gets out there. Congress needs to understand how telecom policy affects not only rural constituents, but also our entire country's network infrastructure and economy."
