#### Our FY 2015 Vision and Purpose.....

In the next 5 months we will connect as many rural Americans as possible to enhanced broadband services through our loan and grant programs with a special focus on advancing all Broadband Initiative Program (BIP) funds by September 30, 2015.

## FY 2015 Vision and Purpose...

- Increasing complement and filling vacancies
- 2 Engineers and 1 Administrative professional came on board in April, 2015.
- Selected a Special Projects Coordinator.
- Promoted 6 Internal staff to various positions.
- In process of hiring more including Financial and Business Loan Specialist, Financial Analysts, Engineers, FCC Specialist, and others.



- Developing outreach workshops to promote economic development through the use of broadband facilities.
- Held one 2 day workshop in Washington State.
- Planning at least 2 more events this fiscal year.

- Community Connect: \$10 million
- Distance Learning & Telemedicine: \$19 million
- Infrastructure Program :\$690 million
- Broadband Program: \$24 million new and \$31 million carryover (\$55 million)



### Infrastructure

- 12 loans approved: \$191 million
- 7 loans pending: \$80 million

### Broadband

Revised broadband regulation has been completed and is in the final stages of the approval process.

It is anticipated that the regulation will be published some time this summer.

### Loan Programs-FY15

- Minimum acceptable level of broadband service establishes a minimum level for which Broadband Service is defined (4 Mbps down and 1 Mbps up).
- Eligible Service Area Reduces the current underserved requirement from 25% to 15%.
- Priority requires the Agency to prioritize applications that offer service to the greatest proportion of unserved households.
- Term if the project is serving an unserved area, the Agency may establish a limited initial deferral period or other term necessary to achieve financial feasibility and long-term sustainability of the project.

### **Portfolio Risk Analysis**

- Risk score developed to measure risk of payment default by telephone borrowers.
- Designed to serve as an early warning system.
- Examined financial data for RUS Infrastructure borrowers active in 2013 over 2008-2013 historical period.

- BCAS/DCS these financial and compliance systems are being combined into a single system and companies will no longer need to submit multiple reports
- Customer Portal this will be a one-stop shop for all your RUS needs

**Information Technology Initiatives** 

- Broadband Opportunity Council (BOC), is Co-chaired by the Secretaries of Commerce and Agriculture.
- The BOC consist of over 25 Federal Agencies and Departments.
- Agencies shall submit to the BOC a comprehensive survey of Federal programs that could assist or can be modified to assists facilitating broadband.
- Public Request For Comment (RFC) was listed last week.
- The BOC will report on initial list of actions taken by agencies to identify and address regulatory barriers, incentivize investment, promote best practices, align funding decisions, and otherwise support wired broadband deployment and adoption.
