**OPASTCO CHAIRMAN/WTA BOARD MEMBER GAILEY TESTIFIES  
BEFORE U.S. HOUSE OF REPRESENTATIVES SUBCOMMITTEE  
ON BROADBAND AND USF REFORMS**

**USF High-Cost Program Should Explicitly Support Broadband**

WASHINGTON – Mark Gailey, chairman of the Organization for the Promotion and Advancement of Small Telecommunications Companies (OPASTCO) and board member of the Western Telecommunications Alliance (WTA) today testified before the U.S. House of Representatives Committee on Energy and Commerce Subcommittee on Communications, Technology and the Internet on the Universal Service Fund (USF) and needed reforms to ensure a robust broadband network infrastructure throughout rural America.

Gailey's testimony urged Congress to reform the USF to include:

- broadband as an explicitly supported service;
- expansion of the USF contributions base to include all broadband and voice connections;
- elimination of the identical support rule;
- removal of the existing cap on the USF High-Cost program; and
- permanent exemption of the USF from the Anti-Deficiency Act (ADA).

"I'm pleased that Chairman Boucher is continuing to show genuine interest in reforming the Universal Service Fund, which is something WTA and the rural telco industry has long advocated," said Kelly Worthington, Executive Vice-President of WTA. "We're moving to a broadband world and USF must move with the country. Reform should take the form of the proposals laid out in Mark's testimony. Reverse auctions and other proposals that would curtail broadband deployment in rural America should be opposed."

“The High-Cost USF program is crucial to a strong rural broadband network, and rural carriers participating in the program recognize both their responsibilities to customers and government’s need to ensure that the funds are invested as intended,” OPASTCO President John Rose stated. “We need to all work together to make public accountability of the High-Cost USF program meaningful and efficient.”
