Ross Bernstein is a best-selling author of nearly 50 sports books, an award-winning peak performance hall of fame business speaker who's keynoted conference for Fortune 500 companies on all seven continents and has been featured on CNN, "CBS-This Morning," ESPN, and Fox News, as well as in the Wall Street Journal, New York Times and USA Today.

Ross' program is all about the DNA of what makes champions in sports so unique and how that relates to business. It's based on a series of books he wrote in which he was able to interview more than 1,000 professional athletes and coaches that all had one thing in common – they were all members of championship teams. In his research he concluded that the same metrics and characteristics that were common among champions in sports, were also common among peak performers in business. There are reasons certain teams win consistently, whereas others don't...Ross explains why. It's based largely on the "Good to Great" concept of how the best companies are able to separate themselves from the rest of the pack through servant leadership, by creating a culture of excellence, by developing deeper relationships, and by giving extraordinary customer service. Ross weaves sports stories, about the DNA of champions, along with stories of companies who he has worked with around the world – and shares best practice ideas on ways to overcome disruption, while ultimately building stronger relationships. At the core of his message is the simple fact that we like to do business with people who we trust, who we like, and who just "get it" – CHAMPIONS.

Tyler Christian Campbell was born October 26, 1986, in Houston, Texas, to Earl and Reuna Campbell. Tyler recalls life-changing words learned from his father at an early age, "A Campbell Never Quits." When confronted with life's obstacles, these words provided strength and encouragement. Tyler received a football Scholarship to San Diego State University in 2005. While attending SDSU, he was a consistent scholar athlete and contributed mightily on the gridiron for the Aztecs. The tides of life came rolling in during his junior year when he was diagnosed with Multiple Sclerosis. Tyler became the first individual to play division one college football with the disease. After graduating from SDSU in 2009, Tyler moved back to Austin. An entrepreneur in his own right, Tyler travels the country as a professional speaker delivering empowering and inspiring messages of self-worth. Coining the phrase "TC Speaks", Tyler hosts his own on air radio show, Real Lyfe Reel Talk, every Saturday from 12pm-1pm on 104.9 The Horn FM in Austin. The inspirational show has become so popular that the Moody School of Communications, at the University of Texas, has hired him on as a consultant to work with students on their semester podcast projects. Tyler and his wife Shana, along with their 3 children, reside in Texas.

Michael J. Balhoff, CFA, is a Senior Partner and co-founder of *Charlesmead Advisors, LLC*, which provides investment banking advisory services with a focus on telecommunications. Before founding Charlesmead Advisors and the predecessor firm to Balhoff & Williams, Mr. Balhoff was Managing Director, heading the Technology and Telecommunications Equity Research Group at Legg Mason in Baltimore, and, in the final seven of his sixteen years as a senior analyst at Legg Mason, he covered equities in the incumbent local exchange carrier industry. Mr. Balhoff has a doctorate in Canon Law and four master's degrees, including an MBA-concentration finance-from the University of Maryland. Mr. Balhoff has been named in six annual awards as a Wall Street Journal All-Star Analyst for his recommendations on the Telecommunications industry.

Carri Bennet has launched several startups, including her own successful boutique communications and technology law firm prior to joining *Womble Bond Dickinson*, Carri Bennet uses her entrepreneurial spirit and smarts to make the often times seemingly impossible achievable. Carri is exacting and persistent in achieving her clients' goals. In that role, she developed a wealth of knowledge on nearly every aspect of running a small commercial wireless company that operated in the United States, the United Kingdom, Denmark, Poland, Sweden, and Germany. She has since translated this experience into better servicing her clients.

Carri testifies before the Federal Communications Commission (FCC), Congress and the courts on rural wireless issues and speaks regularly at industry trade shows and legal seminars on cybersecurity, data privacy, spectrum policy, universal service funding reform and business development and strategy issues for communications and technology companies. She represents her clients before the FCC, state regulatory agencies, the courts and Congress. She has advised clients and industry groups on creating strategic alliances and new business opportunities in the fast-paced world of communications technologies. In 2017, Carri was appointed by FCC Chairman Ajit Pai to serve on the FCC's BDAC Federal Siting Work Group and tasked with making recommendations for improving the timing and processes associated with the siting and deployment of broadband infrastructure on federal lands and buildings.

Dustin negotiated the acquisition of more than 20 companies during the span of 10 years and was a major part of the push from a traditional telco to a multi-faceted provider of broadband, video, and VoIP services.

Currently, Dustin is helping to deploy fiber-to-the-home (FTTH) in numerous communities across central Oklahoma and Texas. He works primarily on mergers and acquisitions and holds various executive roles within Hilliary Communications, Oklahoma Western Telephone Company, Texhoma Fiber, and Southern Plains Cable, among others.

Robert Mayer is Senior Vice President of Cybersecurity & Innovation with the **USTelecom Association (USTelecom)** with responsibility for leading cyber and national security policy and strategic initiatives. He is the current Chairman of the Communications Sector Coordinating Council (CSCC), which represents the broadcast, cable, satellite, wireless and wireline industries in connection with the DHS and public-private partnership activities across the U.S. government. Mayer was serves as co-chair of the Department of Homeland Security's ICT Supply Chain Risk Management Task Force, which is now in its third year and focuses on developing strategic and operational best practices to manage supply chain risk. He also co-leads the Counsel to Secure the Digital Economy (CSDE), which consists of 13 global ICT infrastructure providers who have joined forces to drive solutions that enhance the cyber resiliency of the global digital ecosystem. Mayer was appointed to the FCC Communications Security Reliability and Interoperability Council (CSRIC V), after having led a 100-person team of cybersecurity professionals that produced a landmark report to adapt the NIST Cybersecurity Framework to the broadcast, cable, satellite, wireless and wireline industries.

Prior to USTelecom, Mayer served as the top telecommunications official for New York State as Telecom Director of the New York Public Service Commission. In that capacity, he led several major initiatives including regulatory reform efforts and he created a new agency department that focused exclusively on network reliability and public safety matters. Prior to this appointment, Mayer was the lead regulatory practitioner in the Telecommunications and Cable Group at KPMG

Consulting and was a consultant with Deloitte Consulting. Before that, Mayer worked as an analyst in the international telecommunications divisions of Chase Manhattan Bank and JP Morgan. Mayer served in the US Air Force supervising intelligence and communications operations at NATO Headquarters, Southern Europe in Italy. He received his B.A from Albany State University, his MA in Information Management from Central Michigan University, his MBA from Boston University, and his J.D from New York Law School.

Christopher A. McLean, is the Assistant Administrator for Electric Programs (AAE) at the **Rural Utilities Service (RUS)**. He was named to that position on January 11, 2015. This is Chris' third time at the agency. As AAE, Chris presides over a \$48 billion loan portfolio. In recent years the RUS annual lending budget for new electric infrastructure loans has exceeded \$5 billion. The agency makes low interest loans for rural electric infrastructure, renewable energy generation, smart grid technology, grid modernization and energy efficiency.

Chris is also currently serving as Acting Administrator of the entire agency which also finances water, sewer, telecommunications and broadband infrastructure.

Prior to his return to RUS, Chris was the Acting Director of the Program Planning and Accountability Division of the Office of the Assistant Secretary for Civil Rights (OASCR) at the United States Department of Agriculture. He came to OASCR in 2013 as civil rights fellow in the policy office.

From 2010-2012, Chris served as a senior advisor to the Administrator of the Rural Utilities Service (RUS).

Chris was in private practice from 2001-2010. He was the co-owner of e-Copernicus, a consulting firm that specialized in telecommunications, transportation, and technology policy. Chris is also the former Executive Director of the Consumer Electronics Retailers Coalition (CERC).

Chris is a former RUS Administrator and former Governor of the Rural Telephone Bank. He was appointed Deputy Administrator in January 1998. In 2000, he was the first person nominated and confirmed for the position of RUS Administrator.

Prior to joining RUS, he worked on Capitol Hill for more than 15 years. He served on Senator Jim Exon's staff and Senator Bob Kerrey's staff both from Nebraska.

Chris hails from Omaha, Nebraska. He received an LL.M. in International and Comparative Law from Georgetown University in 1985, a J.D. from Creighton University School of Law in 1982, and a degree in Business Administration from Creighton University in 1980. Chris also completed the Key Executive Leadership Program at American University in 2015.
